

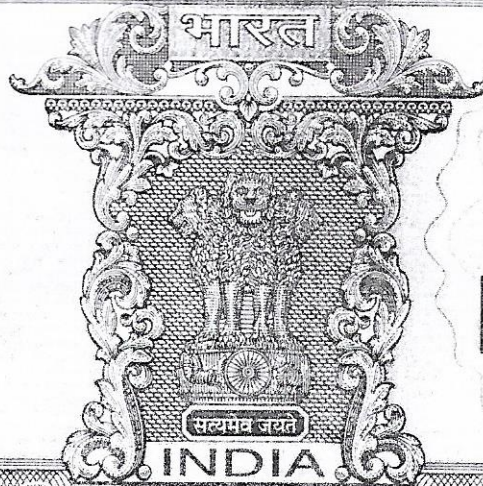

**I. The following clauses of the Memorandum of Association are amended as under:-**

Existing Clause

Amendment Clause

The Executive council shall have power to invest and deal with the money of the association and to borrow such sums of money as it may resolve as tending to benefit the association. All such transactions must be brought to the notice of the General Body of the Association in its immediate next meeting.

The Executive council shall have power to invest and deal with the money of the association and to borrow such sums of money as it may decide for the purposes of the association. Such funds of the association will be invested strictly in accordance with the provisions of section 11(5) E.W.S. 13(1)(d) of the Income Tax Act. All such transactions must be brought to the notice of the General Body of the

If upon dissolution of the association, there shall remain after the satisfaction of all its debts and liabilities and property whatsoever, the same shall not be paid to or distributed among the members of the Association or any of them, but shall be given or transferred to the association or associations, institution or institutions having objectives similar to any of the objectives of this association to be determined by the votes of not less than three-fifths of the members, present personally or by proxy in meeting at or before the time of the dissolution or in default thereof by referring to the High Court of Kerala or any other Principal court of original civil jurisdiction of the district in which the main building of the association is situated at that time.

Association in its immediate next meeting.

If upon dissolution of the association, the assets remaining after the satisfaction of all the debts and liabilities of the association, shall not be paid to or distributed among the members of the Association or any of them, but the same shall be transferred to another Charitable Trust/ Society whose objects are similar to the association and which is registered u/s. 12AA of income Tax Act, at the time of transfer, to be determined by votes of not less than three-fifths of the members present personally or by proxy at the general body or shall be vested with the Government.

### II. The following clauses are added to the Memorandum of Association.

New Clause

The objects/ activities of the Association shall be carried out only in India.

New Clause

The benefits of the association are open to all, irrespective of area, caste, religion, creed, sex, etc.

New Clause

The Society formed is irrevocable.

**III. The following clauses of the Articles of Association are amended as  
under:-**

Existing Clause

Amendment Clause

Article No: XXVI

The books and accounts of the association shall be audited annually and shall be available for inspection of member only at the annual meeting. Accounts and other annual returns, etc. will be submitted annually to the Registrar of Societies as required under Societies Registration Act.

Once in every year, the books of account of the association shall be audited by a qualified Chartered Accountant and shall be available for inspection of the members at the Annual Meeting. The accounts shall be closed on 31<sup>st</sup> March of every year. Accounts and other details shall be submitted to the Registrar of Societies as required under the Societies Registration Act.

## Article No: XXXI

The rules and regulations shall not be repealed, nor any amendment or addition made in the same and rules and regulations of the Association, except by a resolution passed by the votes cast in favour of the resolution by members who being entitled to do so, vote, in person or by proxy or ballot and such votes are not less than three times the number of votes, if any, cast against the resolution by moved in this behalf at least two months prior to the meeting at which such resolutions are to be moved, to the memorandum of the association and rules and regulations thereon will be made in conformity with societies registration act.

Further no such amendments to the memorandum and articles of the association be made which prove to be repugnant to the provision of the Section 2(15) and Section 80G of income Tax Act, 1961. In addition the approved change must be confirmed by a similar majority at a second General Body Meeting convened by the Executive Council after an interval of thirty days after the former meeting.

The Memorandum of Association and Articles of Association of the society shall not be repealed, nor any amendment/ addition made in the same except by a resolution passed by the votes cast in favour of the resolution by members at the general body meeting, not less than three times the number of votes, if any, cast against the resolution. No amendments to any of the clauses of the Memorandum of Association and Articles of Association would be extended to altering the basic character/objects of the Association. Further no such amendments which may prove to be repugnant to the provisions of Sec. 2 (15), 11, 12, 13 and 80G of the Income Tax Act shall be made. All the Amendments/ Additions will be carried out only with the prior approval of the Commissioner of Income Tax having jurisdiction over the association.

All the Members present in the meeting unanimously approved the additions/amendments to the Memorandum of Association and Articles of Association of the Society. It is also decided to apply for registration u/s. 12A of the Income Tax Act, at the earliest.

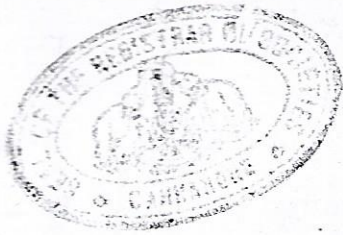


